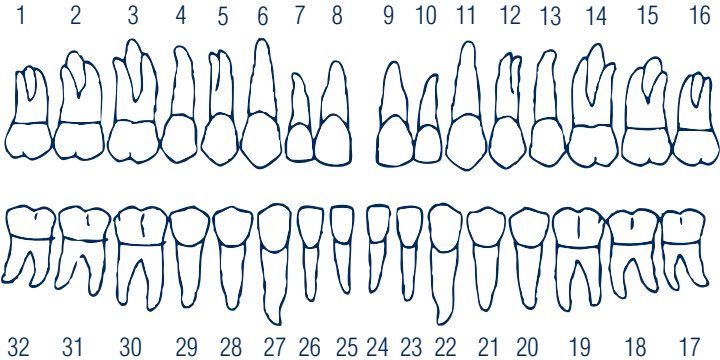

SILVAGGIO ENDODONTICS - ALLENTOWN

From Pocono Area – Take **Route 33 South** to **Route 22 West**. Follow **Route 22** directions.

From Route 22 – Take **Airport Road South** exit. Follow Airport Rd. to the **American Parkway** light. Turn **right** and follow **American Parkway** through 2 traffic lights. Just past the 2nd light, turn **right** onto **Business Park Lane**. Follow **Business Park Lane** down the long straightaway. The office is **on the right** when the road bends.

From South Allentown – Take **Hamilton Boulevard** or **Gordon St.** heading **East to American Parkway**. Turn **left** onto **American Parkway** and follow that across the new bridge over the river and through the light at N. Bradford St. Take the next **left** onto **Business Park Lane**. (If you come to the light at Coca Cola Park, then you've gone too far.) Follow **Business Park Lane** down the long straightaway. The office is **on the right** when the road bends.



EASTON ENDODONTICS, LLC – EASTON

From Route 78 traveling West (from NJ) – Follow **78 to 33 North** to **William Penn Highway**, take exit and turn **right** onto **William Penn Highway**. Follow to **Greenwood Ave.** (Weis Market on the left). Turn **left** at the traffic light. Follow **Greenwood Ave.** to next light and turn **right** onto **Northampton St.** Follow **Northampton St.** to **Corporate Dr.**, turn **right** onto **Corporate Dr.** Take **second right** into parking lot. Main door office **on the left, Suite 1**.

From Route 22 West (from NJ) – Take the **25th St./Wilson Exit**. At the stop light go straight across to next stop light. Go straight across street. Take **second right** into parking lot. Main door office **on the left, Suite 1**.

From 33 South to 22 East (from Pocono's/Allentown & Bethlehem) – Follow **22 East to 25th St./Wilson Exit**. Go to light **turn left** and follow to next light. Then **turn left** again. Follow **Northampton St.** to next light and turn **left** onto **Corporate Dr.** Take **second right** into parking lot. Main door office **on the left, Suite 1**.
